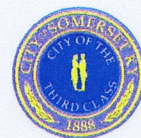

Batteries

- Lead Acid Batteries
- Dry Cell
- Lithium
- Ni-Cad
- Recyclable

Oxidizers

- Pool Chemicals
- Spa Chemicals
- Bleaches
- Hydrogen Peroxide
- Ammonium Nitrate Fertilizer

Mercury

- Free-Liquid
- Thermostats
- Thermometers
- Any Device Containing Mercury
- Mercurichrome

Corrosives

- Drain Cleaners
- Toilet Bowl Cleaners
- Muriatic Acid
- Deck Wash
- Vinegar
- Stop Bath

Solvents

- EEI will pour out as many compatible flammable solvents as they receive; typically these are: Gasoline, Kerosene, Lamp Fluid, & Automotive Fluids

Motor Oil

- All types of oils (exception being PCB Oils) will be bulked on-site

Pesticides/Herbicides

- In either liquid or solid form, EEI will collect and dispose of Pesticide/Herbicide/Insecticide materials. These materials typically include: Lawn Fertilizers, Lawn Foods, Lawn Treatments, Plant Foods, Insecticides, & Rodent Poisons and Killers.

- 20# Gas Grill Type
- 1# Soldering/Small Stove Type
- Larger Propane Tanks
(on a case by case basis)
(must be manufacturer labeled as propane)

Reactives

- Aluminum Paint
- Flammable Solids
- Dangerous When Wet Materials

Fluorescent Bulbs

- 4' and 8' Bulbs (unbroken)
- Compact Fluorescent Lamps– CFL

PCB Materials-

Polychlorinated Biphenyls

- Light Ballasts
- Capacitors
- Free-Liquid Oils (must be marked as such)

Paint

- EEI accepts both Oil-based and Latex Paint

Aerosol Cans

- Any and all types of Aerosol Cans are accepted and recycled by EEI
